MINUTES OF MEETING

HELD February 28, 2022

A public meeting of the Congress Fire District was convened at 7:00 p.m. on February 28, 2022, at the Congress Fire District Office. The following matters were discussed, considered and decided at the meeting:

- 1. Call to Order: Meeting was called to order at 7:05 p.m.
- 2. Roll Call: The following members of the Board of the Congress Fire District were present at the meeting: Jim Sparks, Chairman of the Board was absent, Steve Holloman, Clerk of the Board, and Jane Summers, member.  - b. FC 1 is having some issues when starting it, could possibly be the fuel pressure, we will send it into the shop to determine the issue.
 - c. The department is starting to become short staffed on the weekends due to some reserves starting at other agencies, our full-time/part-time crew members will be filling in those spots as needed.

- 8. New Business: The Redburn Tire Credit and Exemption application was reviewed and will be having the Board Chairman review and sign the document. The documents will allow us to order the tires and have them on a net pay basis and we will be able to use their Service call vehicles if needed.
